Committee Reports

<u>Worship/Ministry:</u> Korinna and Marcus Rosinsky will handle AV duties during the summer to keep things consistent. There is a need for ushers, especially at the 10 a.m. mass during the summer. The scheduling software has been updated to allow for emails to be sent to each minister the week prior to their scheduled service. It also allows ministers to click on the sub list and bring it up to call for a replacement if they can't serve. Babysitting is being considered for the 10 a.m. for those parents who would like to use it. Logistics, such as a designated space, need to be studied. The babysitting would be educational in nature and for ages 0-3 years. Sheila is working on a hospitality project to begin in fall for young children and their families – Create Little Fishermen. This would happen once a month at all masses and would be a search/find activity for families.

<u>Finance</u>: Attendance is down at the 10 a.m. mass which translates into less money in the collection. Since this is the "family" mass, it is a concerning matter for the future of the parish. The Endowment Fund should be used to cover the parish assessment for St. Francis and Roncalli in addition to tuition assistance for parish students. The Diocese is looking at school funding, and it is anticipated that our assessment for St. Francis will increase significantly. The Diocese could also take over management of the Endowment Fund. Roncalli requested help with the purchase of two new buses. St. Peter will give \$12,500 from the Endowment Fund for Roncalli to use toward the purchase of a small bus. According to the parish bylaws, the Secretary Trustee attends the Pastoral Council meetings and the Treasurer Trustee attends the Finance Council meetings.

**Planning Process** <u>Foster Fellowship:</u> No report.

Weekend Experience: No report.

Outreach/Service: Deacon Paul will oversee this committee. Jerry Levanetz is offering a painting class at the parish this fall as a community outreach program. The time and day of the week are yet to be determined. It will run for 6 weeks with a 12 person maximum limit preferred.

**New Business** A suggestion for a parish service would be a small bus or van to be used to pick up parishioners who cannot attend mass because they have no way of getting to church.
